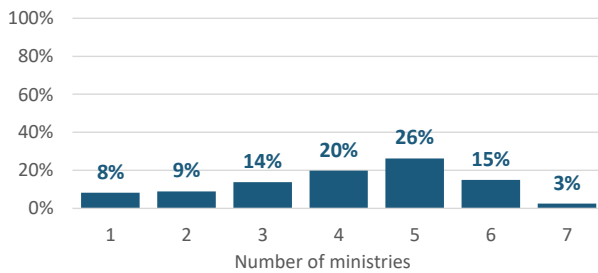

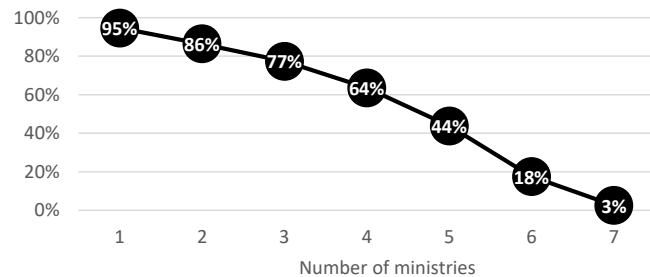

Ministries supported from UPCI churches



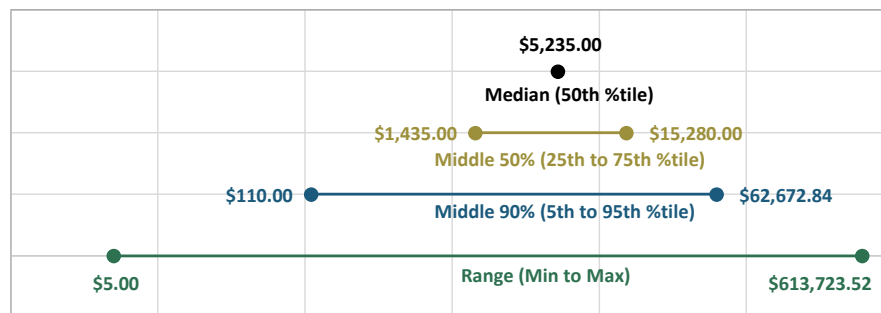
Ministries supported from UPCI churches, Cumulative

3 This report considers a possibility of participating in up to seven possible missional efforts:

Participation in Global Missions includes any giving to I AM GLOBAL or monthly pledges.

Participation in North American Missions includes any giving to Christmas For Christ or monthly pledges.

Participation in Youth Ministries reflects giving to Move The Mission.

Participation in Children's Ministries reflects giving to Save Our Children.

Participation in Ladies Ministries reflects giving to Mothers Memorial.

Participation in Men's Ministries reflects giving to Father's Day Offering.

Participation in Church Advancement includes any giving through The Harvest (SEM) offering, All Nations Sunday offering, or monthly pledges.

4 The annual offering campaigns mentioned above refer to the 2023 offering with one exception. Christmas For Christ reflects the 2022 offering.

5 Total giving churches reflects the total number of self-governing works that were active for at least one offering in the year. If applicable, giving from daughter works and preaching points were counted towards the total of the self-governing mother church.
